



**RESOLUTION NO. 2**

**A RESOLUTION URGING THE SENATE OF THE PHILIPPINES TO FILE THE DRAFT BANGSAMORO BASIC LAW OF THE BANGSAMORO TRANSITION COMMISSION**

**WHEREAS**, under Executive Order No. 08 series of 2016, issued by President Rodrigo Roa Duterte, the Expanded Bangsamoro Transition Commission (BTC) is tasked to draft and spearhead the passage of the Bangsamoro Basic Law (BBL) consistent with the 2014 Comprehensive Agreement on the Bangsamoro (CAB) as a just and lasting solution to the armed conflict;

**WHEREAS**, the BTC has dutifully completed the crafting of the Draft BBL on June 17, 2017;

**WHEREAS**, the BTC formally submitted the Draft BBL to the President on July 17, 2017 in a gathering at Malacañan Palace in the presence of the Senate President and the Speaker of the House of Representatives;

**WHEREAS**, on September 20, 2017 the Legislative-Executive Development Advisory Council (LEDAC) has appropriately included the BTC draft BBL as an approved administration priority Bill;

**WHEREAS**, on August 14, 2017 the Presidential Legislative Liaison Office (PLLO) had formally endorsed the copies of the BTC Draft BBL to the Senate of the Philippines and the House of Representatives, and

**WHEREAS**, the House of the Representatives had already filed the BTC Draft BBL as House Bill No. 6475 dated September 26, 2017.


**NOW**, be it resolved as it is hereby resolved by the BTC in plenary session on January 9, 2018 at BTC Office, 4th Floor, Elena V. Co Building, Don Rufino Alonzo Street, Cotabato City.


**URGING** the Senate of the Philippines or any member of the Senate to file and sponsor the 2017 BTC Draft Bangsamoro Basic Law.




