A RESOLUTION CREATING THE BANGSAMORO TRANSITION COMMISSION (BTC) TASK FORCE RANAW

WHEREAS, under Section 3 of Executive Order No. 08 series of 2016, the BTC is mandated to spearhead the conduct of dialogues and discussions with the public on the Bangsamoro peace process; and to assist in identifying and coordinating development programs in the proposed Bangsamoro areas in coordination with the Bangsamoro Development Agency (BDA) and Bangsamoro Leadership and Management Institute (BLMI), and other relevant government and non-government organizations;

WHEREAS, the May 23 Marawi Siege has resulted to the destruction of Marawi City and displacement of its people which affected the peace and stability of the entire Lanao.

WHEREAS, to address the destruction and displacement, rehabilitation and development of Marawi and other affected areas are currently undertaken by government agencies and non-government organizations, and;

WHEREAS, the BTC may coordinate and conduct dialogues with government agencies and non-government organizations on rehabilitation and development of Marawi and other affected areas in relation to the Bangsamoro peace process.


NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that **BTC TASK FORCE RANAW** is hereby created to conduct dialogue and coordinate with relevant government agencies and NGOs in support of the Bangsamoro peace process and development of the proposed Bangsamoro areas and authorizing the Chairman of the BTC to determine its composition and membership thereof.






